

F.D. Hunter Deed TO Levi A. Gresham

KNOW ALL MEN BY THESE PRESENTS, That I, F.D. Hunter of Greenville County

for and in consideration of the sum of two hundred and fifty Dollars,

Levi A. Gresham of Greenville County (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Levi A. Gresham, a certain piece, parcel or tract of land situate, lying and being in Austin Township, Greenville County and State aforesaid on branches of Horse Pen Creek, branch waters of Enoree River, containing twenty and 1/10 acres, be the same more or less:
Beginning at stone 3XOM; thence N. 11 E. 8.40 to spanish oak on old line of Mrs. Moores 3X
thence N. 76-1/2 W. 9.59 to Pine 3X; thence N. 59 W. 9.36 to a stone on Dawson line 3X;
thence with said line S. 53 W. 10.74 to a stone 3XOM; thence S. 69 E. 26.00 to the beginning stone, bounded by lands of Mrs. Moon, G.P. League, Alex Abercrombie and others.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

Levi A. Gresham, and his heirs and assigns, forever.

AND I do hereby bind myself & my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Levi A. Gresham, and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
