KNOW ALL MEN BY THESE PRESENTS, That I, S.J. Wilson, of Simpsonville,  
 Greenville County in the State aforesaid

for and in consideration of the sum of Fifty Dollars,  
 to me in hand paid at and before the sealing of these presents by

Thos. J. Summer of Greenville County (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Thos. J. Summer, a certain lot, piece, parcel or tract of land situate, lying and being in the Town of Simpsonville Greenville County and State aforesaid on the Greenville and Laurens R.R.:

Beginning at stone on the side Walk 3X; thence S.  $23\frac{1}{2}$  E. 40 feet front to a stone 3X; thence S.  $64\frac{1}{2}$  W. 147 feet to a stone 3X; thence N.  $23\frac{1}{2}$  W. 40 feet to a stone 3X; thence N. 65 E. 147 feet to the beginning stone, containing 660 square yds., bound by lots of W.P. Gresham and S.J. Wilson and others.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Thos. J. Summer, and his heirs and assigns, forever.

AND I do hereby bind myself & my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Thos. J. Summer, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
