

Dicy Levy Deed TO W.W. Putman

KNOW ALL MEN BY THESE PRESENTS, That I, Dicy Levy of Greenville, in the County of Greenville in the State aforesaid in consideration of the sum of (\$100.00) One hundred dollars Dollars, to me in hand paid at and before the sealing of these presents by W.W. Putman (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said W.W. Putman, all that certain piece, parcel and lot of land situate, lying and being in the County and State aforesaid near Woodside Cotton Mill. The same being designated and known as Lot No. 3 on a plat of the Mollie Simpson property, the plat of which is recorded in the R.M.C. office in and for Greenville County in Plat Book A. page 369. The said lot having a frontage of 45 ft. on Endel St. and a depth of 100 ft. on Inman St. This being the same lot as was conveyed to me by Deed under date of Nov. 1st, 1909 by P.S. Butler and recorded in the R.M.C. office in and for Greenville County in Volume 5, page 34.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said W.W. Putman, his heirs and assigns, forever. AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said W.W. Putman, his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof. D. 1910 in the year of our Lord one thousand nine hundred and ten and in the one hundred 35th year of the Sovereignty and Independence of the United States of America.
