in consideration of the sum of Six Hundred & Fifty & 00/100 Dollars,

to us in hand paid at and before the sealing of these presents by

L.A.Mills, (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said L.A.MILLS, All that certain piece, parcel or lot of land situated, lying & being in the City of Greenville, & being a portion of Boyce Addition to Greenville, and having the following metes and bounds according to a plat thereof now recorded in the office of Register Mesne Conveyance for County of Greenville State of South Carolian, in Plat Book at page 179. to wit: Commencing at an iron pin South side North Street joint corner of lots two and three (2 & 3); thence S.15°0' E. along joint lines of said lots One hundred and twenty six feet and one inch (126 feet 1 inch) to an iron pin on ten foot alley; thence N.76°45' E. along said alley fiftyOne feet (51ft) to pin; thence N.15°0' W. One hundred and twenty six feet and one inch (126 ft 1 inch) to pin on North Street; thence S.76°45' W. along North Street fifty One feet to the beginning survey of J.T.Lawrence, revised Jany 22nd 1908 being a portion of lot No.3 block 11.
