in consideration of the sum of Natural love and affection and Five Dollars
to me in hand paid at and before the sealing of these presents by

T.J. Seyle (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said T.J. Seyle, all that certain piece, parcel and lot of land containing one and one-half acres, more or less, situate, lying and being in the County and State aforesaid, about two and one-half miles West of Greenville Court House on the South side of Southern Rail-Road, near the head of Brushy Creek, a tributary of Reedy River and joins lands with J.D. Gillespie, T.J. Seyle and Church St. Being a part of tract which contained three acres, more or less, conveyed to me by Newton Lake, which is more fully described in a deed executed by Newton Lake to Ida J. Seyle and recorded in Book FFF, page 662, R.M.C. for Greenville County, description in said deed being made a part of this deed.
