acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

certain piece, parcel and lot of land known as lot No. 103 of the Verner property, having a
frontage on the Car Line of fifty (50) feet, running back one hundred and fifty (150)

Anna A. Turner, of the City and County of Greenville, and State aforesaid (the receipt whereof is hereby

acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
Anna A. Turner, All that piece, parcel or lot of land having a width of ten feet situated
on the east side of south Meminger Street, of the City of Greenville, County and State aforesaid;
being a strip of land having a width of ten feet on Meminger Street and running along the line
of the property of Anna A. Turner to the depth of 209 feet; said strip of land being taken off
of the Southern portion of a lot conveyed by the Mountain City Land & Improvement Co.,
to John T. Boling by deed dated May 12th, 1903, and being more particularly described by metes
