KNOW ALL MEN BY THESE PRESENTS, That I, Ava I Fortner of the city and County of Greenville in the State aforesaid in consideration of the sum of Two hundred and sixty-five Dollars to me in hand paid at and before the sealing of these presents by J.M. Griffin (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J.M. Griffin, all that certain piece, parcel and lot of land situate, lying and being in the state and county aforesaid and known as Lot no. 17 of plat of Richland Company said plat being recorded in Plat Book "A" page 315. Except a portion of said lot fronting 25 feet on Harris Street and running back 55 feet, cut off from the Northwest corner of the original lot. The deed to that portion sold as aforesaid has not been recorded.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said J.M. Griffin, his heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said J.M. Griffin, his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
