the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said C.R. Bramlett, All that piece, parcel or tract of land situate in Butler Township County and State aforesaid, containing 39-1/2 acres, more or less, and having the following metes and bounds, to-wit: Beginning at a stone, at the junction of the McBee Factory and Austin Roads, thence along Austin Road N. 26 W. 20.50 chains to an angle in said road; thence N. 41 W. 2.00 chains to a stake in road; thence S. 65-1/2 E. 21.80 chains to a stone on the McBee Factory Road; thence N. 41-1/2 E. 11.14 chains to an angle in the road; thence N. 48 E. 11.00 chains to a stake in road; thence N. 6 W. 7.94 chains to a stone in Greenville Road; thence along said road S. 75 E. 2.50 chains to an angle in the road; thence S. 66-1/2 E. 7.50 chains to an angle in the road; thence S. 77 E. 5.50 chains to an iron pin on the corner of the M.M.
