WHEREAS, J. F. Sullivan,

on or about the 7th day of November in the year of our Lord nineteen hundred and thirteen exhibited his complaint in the Court of Common Pleas, for the County aforesaid, against N. A. Whitmore, The Bank of Commerce, Marion B. Beach and Wm. H. Irvine.

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 2nd day of November 1913, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be sold by J. W. Gray, Master in and for the County aforesaid, on the terms and for the purposes mentioned in the said decree as by reference thereto on file in said Court will appear; and the Master, after having duly advertised the said real estate for sale by public outcry on the 2d day of February in the year of our Lord nineteen hundred and fourteen did then openly and publicly, according to the custom of auction, sell and dispose of the same unto J. F. Sullivan,

for the sum of thirty-five Hundred Dollars, being at that price the highest bidder therefor. NOW, THEREFORE, Know all men by these Presents, that I, J. W. Gray, Master in and for County of Greenville, aforesaid, in consideration of the sum of thirty-five Hundred Dollars, to me paid by the said J. F. Sullivan,

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said J. F. Sullivan, all that certain piece, parcel and tract of land situate lying and being in the County and State aforesaid, about three miles west from Greenville about Horse, on the Southern R.R., and containing thirteen and one-quarter acres, more or less, and bounded by said Southern R.R., on the South, by lands of Rockwood Watson on the North and East, and lands of Harrison Holloway on the West, being a part of the Taylor Place; more particularly described in a plat of the said place, made by J. N. Southern, surveyor, and being the same tract of land conveyed to the said N. A. Whitmore by Savina G. Watson by deed, dated November 26th, 1890, and recorded in the R. M. C. office for Greenville County, in Vol. XX, at page 252.
