Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Sallie Rowley, Laura Rowley, and Nannie Rowley, All that certain lot of land situate in the County and State aforesaid, in the City of Greenville, on North Street, known as Lot No. 7 on plat made by W.A. Adams, Surveyor, Jany. 1910, recorded in R.M.C. Office for Greenville County in Plat Book C, page 5, and having the following metes and bounds, to-wit: Beginning at a stake at the corner of North and Glover Streets and running thence along North Street N. 76° 30' E. sixty feet to a stake, corner of lot No. 6; thence N. 21° 45' W. one hundred and eighty feet to a stake on ten foot alley; thence S. 76° 30' W. sixty feet to a stake on Glover Street; thence along said Street S. 21° 45' E. One hundred and eighty feet to the beginning corner. The interest of Sallie Rowley in said lot being an undivided one-half interest, and the interest of Laura Rowley and Nannie Rowley an undivided one-fourth each.
