Adams, Jany. 1910, the following metes and bounds, to wit: Beginning at a stake on Lavinia Avenue corner of Lot No. 10, and running thence along Lavinia Avenue N. 21° 45' W. sixty feet to a stake corner of lot No. 12; thence S. 76° 30' W. One hundred and eighty feet to a stake on Glover Street; thence along Glover Street S. 21° 45' E. sixty feet to a stake corner of lot No. 10; thence N. 76° 30' E. one hundred and eighty feet to the beginning corner, and being known as lot No. 11 on plat above referred to, recorded in R.M.C. Office for Greenville County in Plat Book C, page 5.
