I, J. W. Gray Master in and for the County aforesaid, SEND GREETING:

WHEREAS,

J. Walter Moon, individually, and as Executor of the last Will and Testament of John P. Moon, deceased,

on or about the 28th day of January in the year of our Lord nineteen hundred and fourteen exhibited His complaint in the Court of Common

Pleas, for the County aforesaid, against Mary L. Moon, Ryan Moon, Frank Moon, Maxwell Moon, Edward Pliney Moon and Joe Brown Moon, Mary M. Childs, Elizabeth Frances Ashmore, G. A. Moon, Lula Grace Campbell, Grace Pepper, Frances Pepper, and William Pepper,

demanding that the real estate described in the complaint be partitioned among the parties interested therein; and the cause being at issue, came on to be heard on the 30th day of January 1914, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by

J. W. Gray Master in and for the County aforesaid, to Mary L. Moon and her children for the purposes mentioned in the said

decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. A 4511)

NOW, THEREFORE, Know all men by these Presents, that I, J. W. Gray

Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Mary L. Moon,

and her children, Ryan Moon, Frank Moon, Maxwell Moon, Edward Pliney Moon, and Joe Brown Moon, free from all claims of the other children and grand-children of John P. Moon, deceased. All that certain tract of land situated in Grove Township, County and State aforesaid, containing 170 acres, more or less, and having the following metes and bounds, to-wit; beginning at a stone 3x0m on Blakeley's corner, and running thence S. 76 1/4 E. 50.28 to stone 3x0m; thence N. 16 E. 33.84 to stone 3x0m, near Black Jack; thence N. 77 1/2 W. 9.50 to stone 3x0m; thence N. 70 1/4 W. 11.00 to twin Water Oaks 3x0m; thence S. 51 1/4 W. 2.25 to large Water Oak, 3x0m; thence N. 57 W. 6.90 to Black Gum, 3x0m, near Spring; thence N. 83 1/4 W. 18.57 to twin Post Oaks, 3x0m; thence S. 47 3/8 W. 7.80 to twin Sweet Gum, 3x0m; thence S. 89 3/4 W. 39.4 to stone 3x0m, near double Gum; thence S. 5 E. 24.50 to stone 3x0m, old Sassafras; thence S. 72 W. 4.50 to the beginning corner, save and except a tract containing eight and three-fourths acres, more or less, conveyed by John P. Moon to J. Walter Moon by deed bearing date November 29th, 1910, and having the following metes and bounds, to-wit; beginning on side of road on a stake; thence N. 20 3/4 W. 25.86 to a stone 3x0m; thence S. 5 E. 20.00 to a stone 3x0m; thence S. 72 W. 4.50 to a stone 3x0m; thence S. 76 1/4 E. 12.60 to beginning point, adjoining land of C. M. Blakeley, G. M. Blakeley and John P. Moon, being the tract of land of which John P. Moon died, seized and possessed, known as the Lower Place.

Maxwell Moon, Edward Pliney Moon, and Joe Brown Moon, to be held and used by the said heirs and assigns forever.


