on or about the 9th day of December in the year of our Lord nineteen hundred and fourteen exhibited his complaint in the Court of Common Pleas, for the County aforesaid, against Elizabeth M. Pepper, et al.,

relief as to demanding the real estate described in the complaint; be partitioned among the parties interested therein; and the cause being at issue, came on to be heard on the 8th day of 1915, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman

Master in and for the County aforesaid, to Wade H. Pepper for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. 5016).

NOW, THEREFORE, Know all men by these Presents, that I, E. Inman Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Wade H. Pepper the following described real estate: All that certain piece, parcel and lot of land situated, lying and being in Grove Township, County and State aforesaid, containing 117 acres and being Tract No. 3 of the W. A. Pepper estate according to a Plat made by W. F. See, surveyor, in December 1914, and having the following metes and bounds, to-wit: Beginning at an iron pin in the old Grove road to Piedmont, joint corner of Tract No. 3 and Tract No. 4, and running S. 79 3/4 E. 54.28 to a point on line of Tract No. 1; thence N. 12 E. 26.04 to a stone x 30 m; thence S. 75 W. 2.65 to an iron pin x 30 m; thence along Branch line 24.40 to a poplar 7 3/4; thence N. 8 1/4 W. 8.52 to a stone x 0 m; thence N. 44 W. 4.65 to a stone 3 x 0 m; thence N. 73 W. 11.60 to a stone x 30 m; thence S. 30 1/4 W 5.60 to angle in road; thence S. 19 W. 11.00 to iron pin at the beginning corner.

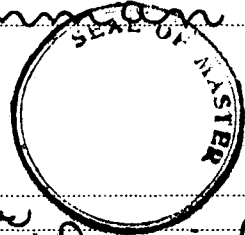
