KNOW ALL MEN BY THESE PRESENTS, That Suburban Land Co.

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Eight hundred & fifty DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

Raven I. McDavid, all that piece, parcel or lot of land being situate in the County of Greenville State of South Carolina, being more fully described as being lot No. 32, Block D. as shown on blue print made by W.A. Adams, Surveyor and known as Sans Souci Villa a subdivision about three miles from Court House on the Buncombe Road and having the following metes and bounds, to wit: Beginning at a pin at the corner of Buncombe Road & Brockman Ave. running N. 10-30 E. 92 feet to a pin being the joint corner of lots No. 32 & No. 33 on Brockman Ave.; thence along line of said Lots S. 57-25 E. 175 ft. to a pin; thence S. 10-30 W. 92 feet to a pin on Buncombe Road thence with Buncombe Road N. 57-25 W. to the beginning corner.

1. It being a part of the consideration that no house shall be built upon this lot to cost less than fifteen hundred dollars (\$1500.00)
2. This property is not to be sold, rented or otherwise disposed to any person of African decent.
3. That no building shall be erected nearer the Street than the building line shown on blue print, which is twenty-five feet from all sidewalks.
4. And nothing which would constitute a nuisance or injure the value of the neighboring lots.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

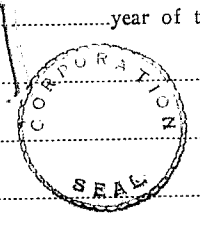
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinafter named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, R.I. McDavid, Pres. T.F. Hunt, Treas. on this the 27th day of July, in the year of our Lord one thousand nine hundred and eleven, and in the one hundred and thirty-sixth year of the Sovereignty and Independence of the United States of America.
