

The Norwood National Bank DEED TO W.D. Browning

KNOW ALL MEN BY THESE PRESENTS, That The Norwood National Bank of Greenville

a corporation chartered under the laws of the United States and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Fifteen hundred DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto...

W.D. Browning, his heirs and assigns all those certain lots or parcels of land situate near the City of Greenville, in the County and State aforesaid, known as a part of the Buist property and described as follows: Beginning at a stake on Mountain View Avenue, joint corners of lots one and two and running thence with said Avenue one hundred feet to a stake, joint corner of lots two and three, thence in a southerly direction along the line of lots three and twelve three hundred and seventy nine feet to a stake on Buist Avenue, corner of lots eleven and twelve thence along said Avenue in a westernly direction one hundred feet to a stake, corner of lots ten and eleven, thence along the lines of lots ten and one, three hundred and seventy nine feet to the beginning corner, being known as lots two and eleven and including that portion of the alley shown on plat, which lies between the lines herein given, said plat being made by W.D.- Neves June the 1st, 1911, and shows the lots above described.

Same being part of the land conveyed to the Bank by Eliza F. Buist by deed dated the 25th, day of May 1911 and recorded in Volume 13 at page 20.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee...hereinabove named, and... his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and his heirs and assigns, against itself and its successors...

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, to-wit: J.W. Norwood, President and S.A. Moore, Cashier on this the 10th, day of October, in the year of our Lord one thousand nine hundred and twelve, and in the one hundred and 37th, year of the Sovereignty and Independence of the United States of America.
