KNOW ALL MEN BY THESE PRESENTS, That We, J. E. Roe and Joel T. Roe, Executors of the will of H. D. Roe of Greenville County.

in the State aforesaid in consideration of the sum of Twenty-two hundred and twenty and no/100 DOLLARS, to us in hand paid at and before the sealing of these presents by

Joel T. Roe, of the State and County aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Joel T. Roe, and his heirs and assigns forever, all that certain tract of land known as Lot number seven in the division of the Real Estate H. D. Roe, deceased, situate in the State and County aforesaid, on the North side of South Tyger River, in O'Neal Township, and having the following described metes and bounds, to wit: Tract number seven or the home place where H. D. Roe resided, and beginning at a stone on road and thence with said road S. 38 W. 8.00 to stone, thence S. 18-1/2 E. 18.50 to stone, thence S. 23 W. 11.00 to stake on Tyger River; thence down the meanders of said River about 16.00 to stake; thence N. 12-1/2 E. 39.50 to stone; thence N. 76-5/8 W. 16.50 to the beginning, containing Fifty five and one-half acres, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
