KNOW ALL MEN BY THESE PRESENTS, That I, O.P. Smith, of the town of Greers, Greenville County in the State aforesaid in consideration of the sum of Five hundred and seventy seven and 50/100 DOLLARS, to me in hand paid at and before the sealing of these presents by

A.Y. Deshields, of Spartanburg County in the State aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

A.Y. Deshields, All that certain piece, parcel and lot of land situate, lying and being in Greenville County, in the State aforesaid, on the Pelham new road and has the following courses, meets, bounds and distances to wit: Beginning at a stake in the center of the road on M.G. Deshields corner and runs thence S. 1/2 W. 3.16 chs. to a stake in center of road; thence S. 83-1/2 E. 7.50 chs. to D.D. Davenports line, thence with his line N. 16-1/2 W. 3.44 chs. to a stake M.G. Deshields corner; thence N. 83-1/2 W. 6.47 chs. to the beginning and contains two and one fifth acres more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said A.Y. Deshields, his heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said A.Y. Deshields, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
