

*Louis H. Harrington* DEED TO *Mattie E. Sparn*

KNOW ALL MEN BY THESE PRESENTS, That *Louis H. Harrington*, of the city and county of Greenville, in the State aforesaid in consideration of the sum of Thirty seven hundred and fifty DOLLARS, to me in hand paid at and before the sealing of these presents by

*Mattie E. Sparn* (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

*Mattie E. Sparn*, all that certain piece, parcel or lot of land situate lying and being in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville on the North side of Pinckney Street and being Lot #3 of a survey, as made by J. N. Southern, D.S., of the estate of W.C. Mcbee, deceased, Plat of same being recorded in P.M.C. office for Greenville County in Plat 13, file "L" at page 73, and having the following metes and bounds to wit—

Begun running at a point on Pinckney street one hundred and four feet from Butler Avenue, corner of Theodore Dehon (now Wallace) lot and running thence with Delphine (now Wallace) line N.  $39\frac{1}{2}$  E. the hundred forty one (41) feet to Mrs. A. Williams line (Dehon's back corner); The line N.  $33\frac{1}{2}$  W. sixty seven and one half (67 $\frac{1}{2}$ ) feet with Williams' line to an iron pin corner of Whitmire's lot; thence S.  $39\frac{1}{2}$  W. with Whitmire's line, one hundred & six (66) feet to Pinckney street; thence with Pinckney street, S.  $50\frac{1}{2}$  E. sixty five (65) feet to the beginning corner this being the same lot of land conveyed to me by R.S. Walker by deed bearing date June 10, 1909, and recorded in P.M.C. office for Greenville Co. in Vol. 14 at page 403.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

*Mattie E. Sparn*, her heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *Mattie E. Sparn*, her

heirs and assigns, against *me* and *my* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
