Johnson of the county and state aforesaid in consideration of the sum of three thousand five hundred & 00/100 DOLLARS, to me in hand paid at and before the sealing of these presents by H. W. Hunt (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

H. W. Hunt All the piece, parcel and lot of land, situate in the State and County aforesaid and within the corporate limits of the City of Greenville, on the North side of Second Alley (Marshall Avenue), and being the western portion of what is known as lot number 8, on plat of J. W. Southern recorded in the Office of the Register of Deed for said County in Book 75, page 64, and bearing the following vertices and bounds to wit: Beginning S. 19° 5' feet N. 65° 28' 6" from street at a stake on Marshall Avenue and running thence N. 65° 28' 6" feet to a stake 34', thence N. 24 1/2 E. one hundred and forty eight feet to a stake 34'; thence S. 65° 28' 6" feet to a stake; thence S. 24 1/2 W. sixty-three feet to a stake; thence S. 11 W. sixteen feet to a stake; thence S. 24 1/2 W. seventy feet to a stake 34'.
