to me in hand paid at and before the sealing of these presents by Lillie Forrester &amp; Alfred Forrester of the State and County aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Relased and by these presents do Grant, Bargain, Sell and Release, unto the said

Lillie Forrester and Alfred Forrester all that piece parcel or lot of land just outside of the corporate limits of the City of Greenville, S. C. Beginning at an iron pin at corner of Monroe Pearson's lot and running thence N. 23 E., 15 feet to an iron pin; thence N. 67 W. 39 feet to an iron pin at corner of Jane Hallman's lot; thence with said Jane Hallman's line 102 3 7 W. 105 feet to Dove street, thence with Dove street S. 67 E. 39 feet to the beginning corner, being a portion of a lot conveyed to me by Frank Petty on March 4<sup>th</sup> 1910, and recorded in the office of Rec. of R.
