is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said
E. H. Tally, all that certain piece, parcel or lot of land situate,

City of Greenville, Ward Six, and having the following metes
and bounds to wit:
