KNOW ALL MEN BY THESE PRESENTS, That I, P.W. Roberts of Greenville County

in the State aforesaid
in consideration of the sum of Five hundred DOLLARS,
to me in hand paid at and before the sealing of these presents by

J.H. Woodside of the State and County aforesaid (the receipt whereof
is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

J.H. Woodside his heirs and assigns all of that certain piece, parcel and lot of land, situate,
lying and being in the State and County aforesaid on the East side of Paris Mountain, adjoining
lands of H.C. Markley, L.M. Hubbard and others, being a part of 8-1/4 acres, purchased by me from
H.C. Markley and having the following metes and bounds: Beginning at a mound of stones on the
East side of the road, being the N.W. corner of the lot bought of H.C. Markley, and running
thence N. 57-1/2 E. 9.20 with H.C. Markleys line to stake on said line; thence S. 27-1/2 E. 5.00
to pine 3x on the line of the 8-1/4 acres, thence with said line S. 52-1/8 W. 9.60 to stone 3xom,
thence N. 28-1/2 W. 5.88 to the beginning, containing five acres, more or less

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

J.H. Woodside, his heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and
forever defend, all and singular, the said premises unto the said J.H. Woodside, his

heirs and assigns, against myself and my heirs, and against
every person whomsoever lawfully claiming or to claim the same, or any part thereof.
