KNOW ALL MEN BY THESE PRESENTS, That I, Robt. Thompson of Greenville County
in the State aforesaid
in consideration of the sum of Three and sixty-one hundredths DOLLARS,
to me in hand paid at and before the sealing of these presents by

John Adair, of the same place (the receipt whereof
is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

John Adair all that lot or parcel of land lying, being and situate in Fairview Township, County
and State aforesaid, containing eighteen one hundredths acres, more or less and hath the
following metes and bounds to wit. Bound by myself and said Adair, Commencing at a stone on
John Adairs line running thence N. 87 W. 3.60 to a stone just across Branch; thence S. 22-1/4
E. .50 to a stone, thence S. 87 E. 3.60 to a stone, thence N. 22-1/4 W. .50 to beginning
corner.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said John Adair, and his heirs and assigns, forever.

AND I do hereby bind myself & my heirs, executors and administrators, to warrant and
forever defend, all and singular, the said premises unto the said John Adair, and his

heirs and assigns, against me and my heirs, and against
every person whomsoever lawfully claiming or to claim the same, or any part thereof.
