 is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Sallie L. Slaten, All that piece, parcel or tract of land situate, lying and being in Oak-  
 Lawn Township, County and State aforesaid, on the waters of Baker's Creek and adjoining  
 lands of Sallie A. Greene, V.D. Hopkins estate and the late W.B. Harrison's lands, said land  
 containing eighty five (85) acres, more or less, and being described as follows:

All that part of my real estate lying north and east of Baker's Creek and adjoining lands of  
 the parties named above, to wit: Sallie A. Greene, V.D. Hopkins' Estate, the late W.B. Harr-  
 ison.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-  
 wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Sallie L. Slaten during  
 her natural life with full power to make absolute disposition thereof in fee by will ~~heirs and assigns, forever~~

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and
