in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said her Coleman, Annie Coleman and Virginia Coleman an undivided one-fourth interest to each of in and to

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville on the south side of Park Avenue, formerly Carrier Street, beginning at an iron pin 378 feet from the west side of Townes Street and running thence with Park Avenue 61 feet to corner of lot no. 5, thence with said lot S. 13 1/2 W. 200 feet, more or less, to a wire fence, thence with line of Misses Ross 63 feet to iron pin, thence with line of lot no. 220 feet to beginning corner, being shown as lot no. 6 on plat recorded in Register's office in Plat Book A, page 261.
