Schuring, all my right, title and interest, (the same being and in the whole of) all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, situate on the south side of College Street in the City of Greenville, and described as follows to wit: Beginning at a stake on Laurens Street and running thence with Laurens Street W. 191/2 E. one hundred and thirty feet and nine inches more or less, to stake at corner of Laurens and College Streets; thence with College Street to the corner of College and Richardson streets; thence with Richardson Street S. 19 N. one hundred seventy five feet and five inches more or less to stake on said street; thence S. 69 E. to beginning corner.
