all that piece, parcel or lot of land in Greenville
Township, Greenville County, State of South Carolina,
near the City of Greenville, in the subdivision known as East Highland surveyed and platted by W.D. Neves, said subdivision being north of the Easley Bridge Road and east of the Piedmont and Northern Railroad, known as Lot No. 12 on said plat, bounded as follows: Beginning at a point seventy-five feet from Hart Street, and running thence in a westerly direction with line of lot No. 13, one hundred twenty-seven feet and five inches to the right of way of the Piedmont & Northern Railway; thence in a southerly direction with the right of way seventy and four tenths feet to lot No. 11; thence in an easterly direction one hundred thirty-three and seven-tenths feet to Carolina Avenue, and thence with Carolina Avenue seventy feet to the beginning.
