said Edward L. Ayers, All that piece, parcel or lot of land in Greenville Township, Green-

ville County, State of South Carolina, in the City of Greenville: Commencing at a stake

on Lavinia Avenue corner of lots Nos. 38 and 39, and running thence N. 21° 45' W. 56 feet

6 inches with Lavinia Avenue to corner of lot No. 40; thence along line of lot No. 40, in a

northeasterly direction 244 feet to a stake on Franklin Avenue; thence with said Franklin
