E.CHILDRESS, of the County of Greenville and State of South Carolina, party of the first part, has granted, bergained, sold and released, and by these present does grant, bargain, sell and release, unto ATLANTA AND CHARLOTTE AIR LINE RAILWAY COMPANY, a corporation, party of the second part, and its successors and assigns, forever.

ALL that certain strip, piece or parcel ofland of the said Childress, situate, lying and being on the northerly side of and adjoining present right ofway of Atlanta and Charlotte Air Line Railway Company for its single track railraod, and on either side of located common center line of proposed new Greenville-Central double track railroad of said Atlanta and Charlotte Air Line Railway Company as the same will extend through the lands of the said Childress, adjoining the lends of T.
