I, E. S. Danner

Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Jessie A. Thompson and Maggie Lee Harling

on or about the 20th day of September in the year of
our Lord nineteen hundred and sixteen exhibited their
complaint in the Court of Common Pleas, for the County aforesaid, against many said stone, et al.

demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 9th day of December 1916; and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. S. Danner Master in and for the County aforesaid, to W. W. Harling and S. W. Danner, Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and for the sum of six thousand (\$6,000.00) Dollars, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

W. W. Harling and S. W. Brooks, the following described real estate, to wit:-

"all that certain piece, parcel and tract of land situated in Sainties Township, County and State aforesaid, about two miles from the town of Simpsonville, adjoining lands now or formerly belonging to D. P. Cox, J. S. Richardson, and others, and containing one hundred acres and more particularly described as follows:

Bract no. 1. containing 65 acres, and having the following metes and bounds, as shown by plat of same made by J. A. Adams, Surveyor, nov. 1st 1916; Beginning at a stone 3X, corner Ed Martin's land; thence N. 61¹/₂ W. 37.40 to a stone 3X; thence N. 12¹/₂ E. 15.40 to a stone 3X; thence S. 80³/₄ E. 19.68 to a stone 3X; thence S. 40¹/₂ E. 36.00 to a stone 3X; Ed Martin's corner; thence with Ed Martin's line S. 30³/₄ W. 11.14 to the beginning.

Also, Bract no. 2, containing 35 acres, and having the following metes and bounds, as shown by plat of same made by J. A. Adams, Surveyor, nov. 1st, 1916; Beginning at a stone 3X, on Ed Martin's line, thence S. 30³/₄ W. 15.06 to stone 3X; thence N. 14¹/₂ W. 26.00 to a stone 3X, Jeff Richardson's corner; thence N. 3 W. 6.16 to stone 3X; thence N. 9 W. 4.14 to black oak 3X, Jeff Richardson's line; thence with said line S. 61¹/₂ W. 28.87 to a stone 3X, Ed Martin's corner; thence with Ed Martin's line S. 21¹/₂ W. 3.00 to the beginning."


