the other lot being the same lot which
was conveyed to R. B. Milby by J. A. Brier
by deed which is recorded in the R. M. O.
Office for the County and State aforesaid
in Deed Book Vol. 26, Page 320. Each of
said lots were owned by R. B. Milby
at the time of his death. Said lots of
land are situate on Judson Alley and
House Street, in Ward Six of Greenville
City.
