the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto

Amanda L. Austin, the following described real  
estate, to-wit:  
"All that lot of land situate on the south  
side of Stone Avenue, in the City and County  
of Greenville, South Carolina, known as lot  
no. 3, as shown by plat recorded in Plat Book
