Frank Eppes of the City and County of Greenville in the State aforesaid in consideration of the sum of Ten Dollars (\$10.00) and other valuable considerations DOLLARS, to me in hand paid at and before the sealing of these presents by O. G. Hicks (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said O. G. Hicks, His heirs and assigns, forever, all those three lots of land situated in Ward Five of the City of Greenville, County and State aforesaid, together fronting 150 feet on the South side of Dunbar Street, and having a depth of 215 feet and containing in aggregate 32,250 square feet, more or less. For a description by metes and bounds and courses and distances see Plat Book "A" page 163 in the R.M.C. Office for said County and State, these parcels of land being numbered on said plat as 6, 7 and 8. Lots 6 and 7 were conveyed to W.W. Willimon by W.H. Irvine, deceased, on June 17th, 1909, by deed recorded in the R.M.C. Office for the County and State aforesaid, in Volume 4, page 468, and lot No. 8 was conveyed to W.W. Willimon by Mrs. Sallie C. Willimon. On Lot No. 6 there is a small store building.
