NOW, KNOW ALL MEN BY THESE PRESENTS, That I E. D. Green

in the State aforesaid
in consideration of the sum of Five Hundred and no/100 DOLLARS,
to me in hand paid at and before the sealing of these presents by B. E. Johnson

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said B. E. Johnson, all that certain piece, parcel or lot of land situate lying and being in the County and State aforesaid in or near the Town of Green and having the following metes and bounds to wit: Beginning at a point on Congress Street at corner of lot No. 10 and run thence with said lot 58.80 feet to corner of lot No. 12, thence along the line of lot No. 12, 199.2 feet, thence 58.8 feet to corner of lot No. 10, thence, along the line of lot No. 10, 5199.2 feet to the beginning corner, being known as lot No. 11 on a plat of land recorded in plat book "A" at page 299.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said B. E. Johnson, his
