NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Mrs. H. J. Dickson of the
City of Greenville, County of Greenville, and in the State aforesaid
in consideration of the sum of nine hundred and 00 (\$900.00) DOLLARS,
to me in hand paid at and before the sealing of these presents by

J. A. Bureton and P. B. Bureton
(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

J. A. Bureton and P. B. Bureton; all that certain
piece, parcel and lot of land situated, lying
and being in ward six (6) of the City of Greenville,
County and State aforesaid, on the east side of
Augusta Street; Beginning at a point on Augusta
Street, joint corner of my lot on which I now live
and the lot owned by the said J. A. Bureton and
P. B. Bureton and running with our dividing
line two hundred and eighty-five feet and
four inches, (285-1/3), to the back line of the lot
of J. A. Bureton and P. B. Bureton; thence in
a straight line in south-western direction
into my lot, in a continuation of the back
line of the Bureton's lot fourteen (14) feet to a
stake; thence in a straight line to a point
on Augusta Street nine (9) feet from the begin-
ning corner; thence with Augusta Street
nine (9) feet to the beginning corner, the
same being a part of the lot on which I
now live and being of the part next the
