(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said  
W. J. Henderson and J. B. Milford,  
all that certain lot or parcel of land situate  
in Greenville County State of South Carolina  
on Augusta Street in the City of Greenville  
and has the following courses and distances.  
Commencing at a stake point near corner  
of J. B. Milford, W. J. Henderson and Mrs. Forenschaw, thence with former dividing line of  
said lots S. 65.10 W. 127.8 ft. to a stake, thence  
by a new line N. 79.0 E. 65.4 ft. to a stake, thence
