(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

n. e. Zockhart a certain tract or parcel
of land lying and being in Glassy
Mountain County of Greenville, S. C. known
as a portion of the Aculeh S. Blue land,
commencing at n. e. Zockhart's corner run-
ning n. w. 6 1/2 rods to road near the Oak
spruce Spring, this line runs with new
road corner stone, thence S. w. 15 1/4 rods to
Mrs. Barker's corner, thence S. E. 39 rods to
corner near Levi Zockhart's house, thence
near S. E. 25 rods to corner near n. e. Zockhart's
