Herman Campbell, all that piece, parcel and tract situate, lying and being in Grove Township, in the County and State aforesaid containing one hundred and six ²/₁₀₀ acres more or less, being all that tract of land which was conveyed to me by R. S. West by his deed bearing date September 30th. 1890, and described in said deed as containing one hundred and sixteen acres more or less, and being all of said tract except nine ²/₁₀₀ acres heretofore conveyed by me to W.
