 to me in hand paid at and before the sealing of these presents by Hallie Stubblefield

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Hallie Stubblefield, and her heirs and assigns forever,
 all that certain piece, parcel or lot of land situate,
 lying and being in the County and State aforesaid,
 near the incorporate limits of the City of Greenville
 and being known and designated as Lot No. 10 Block
 "L" on plat of property of C. C. Mills, deceased, said
 Plat being recorded in Register of Deeds Conveyance
 office of Greenville County in Plat Book "C" at
 page 176. Said lot has the following described
 meter and bounds, to-wit: Beginning at an iron
