NOW, KNOW ALL MEN BY THESE PRESENTS, That I W. H. Shannon

in the State aforesaid
in consideration of the sum of Ten Dollars and other valuable considerations
to me in hand paid at and before the sealing of these presents by R. E. Miller

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said R. E. Miller, all that certain piece, parcel or lot of land situate lying and being in the County and State aforesaid, in Ward One of the City of Greenville, on the South side of Hampton Avenue, and having the following metes and bounds to wit: Beginning at an iron pin 305 feet North-west of the intersection of Hampton Avenue and Frank Street and running thence with Hampton Avenue N. 32-25 W. 52 feet to an iron pin the corner of a ten-foot alley; thence with line of said alley S. 57-35 W. 140 feet to an iron pin on a ten-foot alley thence S. 25 W. 52 feet to an iron pin on line of lot No. 5; thence with line of lot No. 5, N. 57-35 E. 140 feet to an iron pin on Hampton Avenue the beginning Corner, left being lot No. 6, according to a map of property of T. C. Sowers by W. D. News, dated October 1912, and recorded in Plat Book "C," Page 437C, M. C. Office for Greenville County.

Being the same lot of land conveyed to me by T. C. Sowers by deed dated October 10th 1918 and recorded in the R. M. C. Office for Greenville County in Vol. 44 Page 254.

The alley first above mentioned is to remain open hereafter.

AND I do hereby bind myself my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said R. E. Miller, his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
