KNOW ALL MEN BY THESE PRESENTS, That We, J. R. Vandiver and D. S. Vandiver, of the City of Anderson, County of Anderson

in the State aforesaid,

for and in consideration of the sum of five hundred dollars (\$500.00) in hand paid to us by H. P. McKee, of the County of Greenville

at and before the sealing of these presents by H. P. McKee, of the County of Greenville

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

H. P. McKee; All that certain lot or parcel of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the West side of Tourges Street known as Lot Number Eleven (11) low plat of the De Camps property recorded in Office of R. M. C. County and State aforesaid, in Deed Book 55 page 679, being the same lot conveyed to the grantors herein by Mrs. Josee G. Frank and conveyed more fully described in said deed of conveyance recorded in said R. M. C. Office in Book 53 of Deeds page 32 beginning at a point on Tourges Street 75 feet from the corner of Marshall Avenue and having a frontage of 75 feet on Tourges Street, and other metes and bounds do appear in said plat, being the lot containing two buildings used for residence purposes.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said H. P. McKee, his heirs and assigns, forever.

AND We ourselves, our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said H. P. McKee, his heirs and assigns, against us, our executors administrators and all other persons heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
