(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

A. B. Cannon, all that certain piece parcel and tract of land situate lying and being in the State and County aforesaid, Highland Township, adjoining lands of I. F. Reece, I. F. Frew and being a part of the same land conveyed to I. F. Reece and Ignatius Frew, by Benjamin Frew and Ignatius Frew, Executors, by deed bearing date of Nov. 12th 1883 and recorded in the files of the N. M. C. of Greenville County in Vol. 1183 at page 11 and having the following courses and distances, metes and bounds; Beginning on a stone and chestnut stump, I. F. Frew's corner and runs thence N. 47.
