KNOW ALL MEN BY THESE PRESENTS, That We, Alice E. Freeman, Executrix and J.T.R. Neal, Executor of the last will and Testament of W.P. Poole, deceased of Greenville County,

to us in hand paid at and before the sealing of these presents by Alice E. Freeman, of the City of Greenville,

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Alice E. Freeman, her heirs and assigns, All that certain piece, parcel and lot of land situate, lying and being in the County of Greenville, State of South Carolina, and in Greenville Township, just beyond the City limits of Greenville, and just west of the Southern Railway, having the following metes and bounds, to-wit: Beginning at an iron pin on road, corner of lot No. 3 and running thence S. 49 1/2 E. 34 feet to an iron pin on said road; thence S. 43 E. 27 1/2 feet to corner of lot No. 5; thence N. 31 1/2 E. 107 feet to a stake; thence in a southwestern direction 146 feet to beginning corner, the same being designated and known as lot No. 4 of survey made by W.A. Hulson, December 30th, 1904.

Also all that other certain piece, parcel and lot of land situate, lying and being in Greenville County, State of South Carolina, in Greenville Township, just west of the corporate limits of the City of Greenville, known and designated as lot No. 3 on a plat prepared by W.A. Hulson, December 30, 1904 and having the following metes and bounds, to-wit: Beginning with side of old road which was formerly a continuation of West Street (now Hampton Avenue) two hundred and forty-five (245) feet from the center of the Main Line track of Southern Railway company, and running thence N. 33 1/2 E. one hundred and eighty-four (184) feet to a stake on line of Mrs. Nancy Johnsons land; thence along her line N. 68 W. sixty-six (66) feet to a stake; thence S. 33 1/2 W. one hundred and sixty-one (161) feet to a stake on North side of said old road; thence S. 49 1/2 E. along said old road sixty-five (65) feet to the beginning corner, containing 10,664 square feet, more or less, and being part of the land conveyed unto Lydia Poole by Leola A. Watson, by deed bearing date August 10th, 1906, This deed being executed by the Executrix and Executor by virtue and in pursuant of the power so vested in us by said Will, said Will being filed in the office of Probate for Greenville County, in Apartment 118 File 15.
