in consideration of the sum of Three Thousand (\$3000.) DOLLARS,

to us in hand paid at and before the sealing of these presents by A. H. Magill

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

A. H. Magill, all that certain lot of land situate on Lloyd Street in the City of Greenville County and State aforesaid, known as lot 10 on Plat of the property of Fred W. Symmes and having the following metes and bounds to wit: Beginning at a wire pin on Lloyd Street, joint corner of lots 9 and 10 and running thence with Lloyd Street S. 55.40 N. 58 feet to a wire pin, joint corner of lots 10 and 11 thence with line of lot 11 N. 37.10 W. 144 feet to a wire pin in line of lot 12; thence N. 54.15 E. with line of lot 12 58 feet to a wire pin in said line; thence with line of lot 9 S. 37.10 E. 139 ft. 6 in. to the point of beginning.
