KNOW ALL MEN BY THESE PRESENTS, That *I Shillie H. Martin*

in the State aforesaid,  
in consideration of the sum of *Twenty-three hundred forty-five (\$2,345.00)* DOLLARS,  
to *me* in hand paid  
at and before the sealing of these presents by *Teb. Sloan*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*Teb. Sloan, his heirs and assigns,*  
all that piece, parcel or lot of land in the City of *Greenville*, State and County aforesaid, on the North side of *Mills Avenue*, in the sixth ward of the City, known and designated as lot # 11 of Block B, of Eagle Park Company, as shown on plat recorded in R. M. S. office for *Greenville* County in Plat Book C, page 238, and having the following metes and bounds to wit: Beginning at an iron pin on the North side of *Mills Avenue*, corner of lot # 12, running with line of lot # 12 N. 3-05 E. one hundred fifty-eight and two-tenths (158.2) feet to an iron pipe; thence South 89.07 degrees two feet to an iron pin; thence S 4.56 E one hundred fifty-seven and eight-tenths (157.8) feet to an iron pin on *Mills Avenue*; thence with *Mills Avenue* N. 89-40 East sixty-seven feet to the beginning corner, subject however to the following restrictions which are a part of the considerations for this deed, and are for the benefit and protection of the other lots shown on the plat above referred to, which restrictions shall remain in force for a period of twenty years from June 16th, 1918 to wit:  
1. The property herein conveyed or any part thereof shall not be sold, rented or otherwise disposed of to Negroes.  
2. The said property shall not be used for any unlawful business or anything which would constitute a nuisance.  
3. The property herein conveyed shall not be re-cut or sub-divided so as to face any other direction than shown on said plat.  
4. No building shall be erected on said property within twenty-five (25) feet of the present line of *Mills Avenue*.  
5. No building costing less than Thirty-five hundred (\$3,500.00) dollars shall be erected upon said lot, other than outbuildings, appurtenant to a dwelling.  
The above described land is the same lot conveyed to me by *U. J. Gaughan* by deed dated February 10th, 1919, and recorded in the R. M. S. office for *Greenville* County on February 18th, 1919, Book 50, page 231.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *Teb. Sloan, his*  
heirs and assigns, forever.

AND *I myself, my* do hereby bind  
heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *Teb. Sloan, his*

heirs and assigns, against *me* and  
*my* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
