KNOW ALL MEN BY THESE PRESENTS, That I, Mary L. Pack of Greenville in the County of Greenville and

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Thomas J. Goldenmith, All that lot or parcel of land situate in the County and State aforesaid, near the City of Greenville, on the Augusta Road, beginning at a stake on the north side of said road and running thence with said road 3.73, to a stake 32; thence N. 63 E. 9.66 to a stake 32; thence N. 27 W. 3.50 to a stake 37; thence S. 63 W. 11.00 to the beginning corner, containing three and 56/100 acres more or less and known in the division of a tract formerly owned by P. D. Curton, deceased, as at W. 2.

Also that other lot known on said plat and division as lot no. 3, adjoining the lot above mentioned, with the exception of one-half acre which was conveyed therefrom by Lucy Emma Curton to W. D. Mettles by deed dated December 5th 1900 and recorded in Vol. 46, page 517, in R. M. C. office for said County.

The two lots herein conveyed were conveyed to me by Lucy Emma Curton by deed, dated April 30, 1917, and recorded in said office in Vol. 46, page 209. The plat hereinabove mentioned is recorded in said office in plat book "E" at page 33. As a part of the consideration hereinabove expressed, the grantee herein is to assume and pay a note and mortgage executed by Mary L. Pack to Lucy Emma Curton, dated April 30, 1917 for \$10,000.00 and recorded in said office in Vol. 66, page 23, on which there is now a balance of \$7,000.00, with interest as therein stated, from April 30, 1919. And it is further understood that all taxes for 1919 are to be pro-rated.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.  
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Thomas J. Goldenmith and his heirs and assigns, forever.

AND myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Thomas J. Goldenmith and his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
