

Gillette Gordon Harris DEED TO Nona Harris Squires  
 STATE OF SOUTH CAROLINA,  
 COUNTY OF Greenville  
 KNOW ALL MEN BY THESE PRESENTS, That I, Gillette Gordon Harris, of the County of Culpepper State of Virginia,

in the State aforesaid,  
 in consideration of the sum of Six thousand and no/100 DOLLARS,  
 to me in hand paid  
 at and before the sealing of these presents by Nona Harris Squires of Laurens County, in the State aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

Nona Harris Squires, - The following pieces, and parcels of land, to-wit:  
 1st: All that certain lot or parcel of land, together with all and singular the buildings and improvements thereon, situate, lying and being on the east side of Augusta Street, in the City of Greenville, Greenville County, South Carolina, bounded and described as follows, to-wit: Beginning at an I.P. 3X 168' South of the 3X of Elkins Street, and running thence with Augusta Street 50 deg. 30' E. 54' to an I.P. 3X of Whitwire lot; thence East with said lot 100' to an I.P.; thence N. 0 deg. 30' W. 53 ft. to an I.P. 3X; thence N. 89 deg. 45' W. 100' ft. to the beginning 3X. Same being a portion of the real estate wherof the late Mrs. Fannie E. Harris died seized and possessed and which was conveyed by all the heirs-at-law of the said Mrs. Fannie E. Harris, deceased to the said Sallie Hart Harris, as their attorney-in-fact, as aforesaid, with full power and authority to make conveyance thereof by good and sufficient deed - to which said Power of Attorney duly recorded in said Clerk's Office, reference is hereby made. This being the same lot heretofore conveyed by Sallie Hart Harris, Attorney in fact to me by deed dated 23rd. of July 1914, and recorded in Deed Book 16, page 177 in the office of the R.M.C. for Greenville County, South Carolina.  
 2nd: All that certain lot, piece or parcel of land situate, lying and being in the County of Greenville, State of South Carolina, and near the City of Greenville, and containing twenty-two and three-tenths (22,3) acres, more or less, and bounded on the North by Sumter Street on the East by right-of-way of the Piedmont & Northern Railway Company, on the South by blank, and on the west by Washington Avenue. Said lot is more fully delineated on the plat of West Highland, made by W.D. Neves, Engineer, and dated Jan. 24th, 1916 as Lot No. "M", said plat being recorded in plat book C., at page 253-259 in the office of R.M.C. for Greenville County, and is one of the lots conveyed to me by the heirs-at-law and distributees of Mrs. F.E. Harris, deceased, and grantees of J.M. Harris by deed which is recorded in Vol. 37, page 452 in the office of R.M.C. for Greenville County.  
 3rd. All those certain lots, pieces, and parcels of land situate, lying and being in Greenville County, South Carolina, near the City of Greenville, and known as part of the East Highland Property, and being numbered on plat of said East Highland property made by W.D. Neves, Engineer, and dated Jan. 1914; recorded in Plat Book C., at page 146 in the office of R.M.C. for said County and State as numbers fifty-nine (59), sixty-one (61), sixty-four (64), sixty-seven (67) and seventy-one (71), and being lots conveyed to me by the heirs at law and distributees of Mrs. F.E. Harris, deceased, and the grantees of J.M. Harris, in and by deed dated 28th, day of Jan. 1916, and recorded in Deed Book Vol. 37, page 452 in the office of R.M.C. for said County and State.
