(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

John L. Bussey, all that certain lot of land situate on the southwest corner of Pendleton and Summer streets in the 5th ward of the City of Greenville, County and State aforesaid, more particularly described, as follows: Beginning at a steel pin on the south west corner of said streets and running thence with Pendleton street N. 73 W. 80 feet to an iron pin, thence S. 17 W. 151 feet 9 inches to iron pin in the line of lot of Marion B. Beach thence with Leach's line S 73 E 80 feet to an iron pin, thence with Summer Street N. 17 E 151 feet 9 inches to the beginning corner, being the lot of land conveyed to me by C. W. Estis by deed dated June 13, 1919, and recorded in Office of R. W. C. for said county in Vol # 45 page 374. And the said John L. Bussey does, as a part of the consideration of this deed, assume the payment of the two following mortgages which were executed by the said B. E. Estis.

(1) A mortgage to A. B. Furman - assigned to W. E. Beattie dated Oct 5, 1916 for \$8,000.00 interest at seven per cent, payable semi-annually; (2) A mortgage to Mary S. Brantley, dated Oct 9, 1916 for \$2,500.00 interest at seven per cent semi-annually.
