All that lot of land situate on the Southwest side of Perry Avenue in the City and County of Greenville, South Carolina, beginning at a point on said Avenue 199.3 feet from the corner of Ware Street and said Ave. and running said line in a westerly direction of 55 feet. It has a depth of 148.4 feet and is 56 feet wide at the back. Said lot is a part of two lots conveyed to W. W. S. Orr by W. C. Beattie and W. L. Odiorne, recorded in Volume 666 page 727 and 728 page 711, respectively.

The said W. W. S. Orr departed this life intestate leaving the grantor and his daughter Mary Mildred Orr as sole heirs at law and distributees.
