KNOW ALL MEN BY THESE PRESENTS, That Agnes L. McGee

in the State aforesaid,

in consideration of the sum of

One Hundred Dollars and other valuable consideration DOLLARS,

to me in hand paid

at and before the sealing of these presents by Laurie P. Adams, in the State aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

Laurie P. Adams her heirs and assigns, All that certain piece parcel or lot of land situate lying and being in Ward One of the City of Greenville County, and State aforesaid on Buncombe Street and having the following 'metes' and bounds to wit: Beginning at an iron pin on Buncombe Street at the corner of lot heretofore conveyed by J.D. Bridges to A.P. Gutz and running thence with Buncombe Street 230.41 E. 60.9 feet to an iron pin corner of Symmes' property, thence with Symmes' line N. 69.16 E. 118.2 feet to an iron pin, thence N. 13.15 W. 75 feet to an iron pin, corner of lot heretofore conveyed by J.D. Bridges to said A.P. Gutz, thence with his line 141 feet to the beginning corner, and being a part of the land conveyed to J.D. Bridges by J. W. Nix et al. see deeds recorded in Deed Book Vol. 281 pages 203, 204 and 205, and is the same lot of land conveyed to W.A. Merritt J.E. Johnston and A.L. McGee by W.H. Griffin by deed dated June 19-1916 and recorded in the office of the P.M.C. in Vol. 41 page 68, Sept. 4th 1916, and being the same lot of land conveyed to me (Agnes L. McGee) by W.A. Merritt J.E. Johnston and A.L. McGee by deed dated January 23-1917 and recorded in the office of the P.M.C. of Greenville County in Vol. 36 page 249.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Laurie P. Adams, her

heirs and assigns, forever.

AND myself, my heirs, executors and administrators, do hereby bind

to warrant and forever defend, all and singular, the said premises unto the said Laurie P. Adams, her

heirs and assigns, against

myself, my heirs, executors and administrators, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.

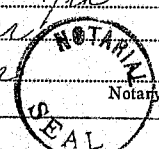
